



(Fig.1) Standard Booth with Basic Decoration



(Fig.2) Standard Booth Share Plan with basic decoration



#### 2. Free Panels

Using system panels, partition walls (back and both sides) will be installed. Panels and partitions can be removed upon application. However, no discounts will be offered for removed panels and partitions.

3. Basic Decoration Service Free basic decoration service will be offered to every overseas exhibitor (Fig.1, 2). All additional decorations or construction costs will be at exhibitors' expense.

#### Remarks about Exhibition

- 1. Height restriction: Booth height shall be lower than 2,500mm. Any decorations higher than 2,500mm must meet certain conditions. Please contact us.
- 2. Booth assignment shall be made by the secretariat taking into consideration, type of industry, exhibit content and composition.
- 3. Any of the assigned booths cannot be transferred, rented out or exchanged.

#### Payment

- 1. Please pay the booth charge by the date designated by the secretariat.
- 2. Exhibitors who need electric work need to pay a separate charge. For more details, please check our website.
- Change of Exhibition Application and Cancellation
- 1. The number of booths cannot be changed after the application deadline.
- 2. In case of cancellation after the application deadline, a cancellation fee will be charged. Please contact the secretariat.
- 3. No refunds for cancellation after payment.
- 4. Anticipating exhibitors may be declined from exhibiting if application content deemed not suitable.

#### Others

- 1. Maintenance: Please strive for accident prevention during the fair, including installation, cleaning-up, exhibiting, and demonstrations. Although the secretariat is in charge of management of the hall, it is strongly recommended for exhibitors to insure the exhibition items, in case of damage or loss by theft, fire, natural disaster, accidental force etc.
- 2. Demonstration: Although demonstration of exhibition items are free, it may be restricted or stopped if it is found to be causing any trouble for venue operations.
- 3. Carrying in of dangerous items: Exhibitors who plan to bring dangerous objects (flammable objects such as high pressure gas or liquefied gas) defined by laws of Japan into the site must submit required documents to the secretariat for preliminary review by the fire department.
- 4. Sale or distribution of exhibition items: Sale is admitted. However, large size items requiring special handling shall not be approved for sale. / Distribution of catalogs, explanatory material, product samples, sales promotion goods, etc. are only admitted at exhibitor's booth.
